**WHEREAS:**

- 1 **Alpha Seniors Home**, working on different issues of Old Age, Elder Care, Geriatric Issues, Constuctive Living, etc. was founded in 2020 for providing benefits of parents care, retirement and assisted living Facility to senior citizens, as part of their ongoing activity.
- 2 **St. John College of Engineering and Management, Master of Management Services (MMS) Department** is an educational institution established in 2008, affiliated to Mumbai University. The College offers various Post Graduate Courses in Management Studies.
- 3 St. John college of Engineering and Management, Master of Management Studies (MMS) Department wishes to enter into a **Memorandum of Understanding (MOU)** with NGO Alpha Seniors Home for the skills enhancement initiative through Social Consciousness and other face to face initiatives.

**NOW IT IS HEREBY AGREED BY AND BETWEEN THE PARTIES HERETO AS UNDER:**

**1 Objective:**

The objective of this MOU is to enable students of St. John College of Engineering and Management college, MMS Department to access resources that would enhance their social consciousness.

**2 Validity of MOU:**

This MOU shall come into force and effect from the date of execution and shall be valid from such date after which the same may be reviewed by either party. However, this MOU shall remain valid until it is expressly terminated by either party on mutually agreed terms.



### **3 Roles & Responsibilities of the College:**

- a. The College shall be responsible to nominate one person with adequate accountability and responsibility to coordinate the engagement.
- b. The College shall share details such as name, email ID, contact details of the students who are willing to undergo the aforesaid skill enhancement initiative through social consciousness with the NGO on the College Letterhead.
- c. It would be the responsibility of the College to ensure that proper publicity of the program is made through College website.
- d. The college should encourage the students by informing them about the benefits of the program.
- e. All required support and Guidance should be provided to NGOs during the conduct of the said training program.

### **4 Roles & Responsibilities of NGOs :**

- a. NGO shall be responsible to provide access to social awareness programmes championed by NGO. They shall also be responsible for allocation of task and field work, enhancement of social consciousness and other related activities, either in the field or NGO Office premises for mutually agreed fixed period/days during the period of the Academic Year, by the NGO Coordinator or Institution Programme Officer.
- b. NGO Should arrange for regular written feedback and assessment.

### **5 Other Terms & Conditions:**

Following are the other terms and conditions of MOU:

- a. The students enrolled should complete the Samarpan (NGO) program as scheduled.
- b. Institution Program Officer to be appointed by college institution.



- c. NGO Programme Coordinator's active support and participation is required for smooth & efficient conduction of the program
- d. The College shall not write/publish any material or use any logo/name of the NGO in any of the publications without prior written consent and approval from the NGO..

#### **6 Certification:**

Letters of Recommendation or Certificates of Participation shall be awarded by the NGO to the students on successful completion of the Samarpan Activities.

#### **7 Limitations and Warranties :**

Both parties agree that it would be their endeavour to prevent any liability arising out of default or non-compliance of the MOU terms by the other party.

#### **8 Termination:**

Both parties can terminate this MOU with a prior-written thirty (30) days notice on default of terms of non-adherence to any condition or responsibilities by the other party as outlined in this MOU.

#### **9 Confidential Information:**

- a Both parties undertake to each other to keep confidential all information (written or oral) concerning the case studies of inmates, videos, victims, Child etc.
- b In the event of any of the parties becoming legally compelled to disclose any confidential information, such party shall give sufficient notice to the other party so as to enable the other party to seek a timely protective order or any other appropriate relief. If such an order or other relief cannot be obtained, the party being required to make such a disclosure shall make the disclosure of the confidential information only to the extent that is legally required of it and no further.



- c Both parties agree not to deal directly or exchange any details without prior written permission of incharge and trustee of NGO, even after the agreement has been terminated and not earlier than two years from the date of termination.


