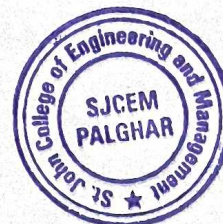

WHEREAS:

1. **Saanidhaanam ALF**, backed by Sundar Jessaram Kataria Foundation. Reg No: E-25212, 80G IT Reg No.: 1289. The main vision of the NGO is to address the emotional, intellectual and social dimensions of people with disabilities and senior citizens, by providing a residential home, companionship, care givers and medical support; thus enhancing their quality of life with the aim to reach out to the most vulnerable section of society.
2. **St. John College of Engineering and Management, Master of Management Studies (MMS) Department** is an educational institution established in 2008, affiliated to Mumbai University offering Post Graduate Degree Courses in Master of Management Studies.
3. St. John College of Engineering and Management, Master of Management Studies (MMS) Department is willing to enter into a Memorandum of Understanding (**MOU**) with NGO Saanidhanam for the skills enhancement initiative through Social Consciousness and other face to face initiatives for its MBA students.

NOW IT IS HEREBY AGREED BY AND BETWEEN THE PARTIES HERETO AS UNDER:

1. **Objective:**

The objective of this MOU is to enable students of St. John College of Engineering and Management college, MMS Department to access resources that would enhance their social consciousness.

2. **Validity of MOU:**

This MOU shall come into force and effect from the date of execution and shall be valid from such date after which the same may be reviewed by either party. However, this MOU shall remain valid until it is expressly terminated by either party on mutually agreed terms.



- c. NGO Programme Coordinator's active support and participation is required for smooth & efficient conduction of the program.
- d. The College shall not write/publish any material or use any logo/name of the NGO in any of the publications without prior written consent and approval from the NGO.

6. Certification:

Letters of Recommendation or Certificates of Participation shall be awarded by the NGO to the students on successful completion of the Samarpan (NGO) Activities.

7 Limitations and Warranties :

Both parties agree that it would be their endeavour to prevent any liability arising out of default or non-compliance of the MOU terms by the other party.

8 Termination:

Both parties can terminate this MOU with a prior-written thirty (30) days notice on default of terms of non-adherence to any condition or responsibilities by the other party as outlined in this MOU.

9 Confidential Information:

- a. Both parties undertake to each other to keep confidential all information (written or oral) concerning the case studies of inmates, videos, victims, Child etc.
- b. In the event of any of the parties becoming legally compelled to disclose any confidential information, such party shall give sufficient notice to the other party so as to enable the other party to seek a timely protective order or any other appropriate relief. If such an order or other relief cannot be obtained, the party being required to make such a disclosure shall make the disclosure of the confidential information only to the extent that is legally required of it and no further.



- c. Both parties agree not to deal directly or exchange any details without prior written permission of in-charge and trustee of NGO, even after the agreement has been terminated and not earlier than two years from the date of termination




