This Memorandum of Understanding (MOU) made at Palghar this 13<sup>th</sup> Day of December 2019 between Aldel Education Trust, which is registered under Bombay Public Trust Act, 1950 at Mumbai and having its registered office at S/2, West Avenue Co-op Society Ltd. Holy Cross Road, IC Colony, Borivali (West), Mumbai-400 103 represented by its Chairman, Mr. Albert W. D'Souza, herein, after called the 'First party' (which expression shall unless repugnant to the context or meaning thereof mean and include Trustees, Survivor of them, their successors in office and assigns) of the first part and

Dhawale Memorial Trust Rural Homeopathic Hospital, Palghar represented by its Director Dr. Anand Kapse, hereinafter called the second party (which expression shall unless repugnant to the context or meaning thereof mean and include his successors in office and assigns) of the second part.

Whereas the first party owns St. John College of Engineering and Management, St. John Institute of Pharmacy and Research, St. John College of Humanities and Science, St. John Junior college, St. John International School situated in their St. John Technical Campus, Village Vevoor, Manor Road, Palghar (East) Palghar District, Maharashtra-401 404.

And Whereas First party is desirous of availing Emergency Medical Services to their staff members and students as and when required, the first party has requested the second party to provide Emergency Medical Services to staff and students referred by them and the Second Party has agreed for the same which they desire to reduce to writing.

Now this Memorandum of Understanding witnesseth as follows.

1. This MOU will be operative from 1<sup>st</sup> January, 2020.
2. The First party will refer its employees/students as and when the emergency medical Services are required.
