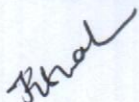

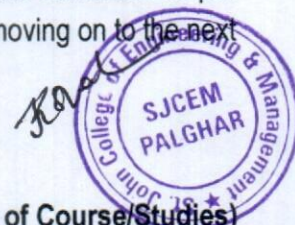

ROUND FOR GENERAL MERIT LIST

The Admission round starts at sharp 10.00 a.m. onwards.

The guidelines for reporting are as follows:

1. Reporting timing for all eligible candidates as per merit list on 13th September 2026 is between 08.30 a.m. & 10.00 a.m. only. All students whose names appear in the Merit List and are desirous of seeking admission should ensure that they are present at the College before registration closes at 10 a.m.
2. The candidate must be physically present along with the parent. If a guardian is present in place of the parent, they should carry an authority letter duly signed by the parent, authorizing the guardian to complete the admission process.
3. The candidate must provide original Documents/Retention letter for verification. The candidate must also bring two complete sets of photocopies of all documents to the counselling round.
4. The candidate must pay the admission fees as described in the Fees section above.

Your admission confirmation is subject to verification of your eligibility, submission of original documents and successful payment of fees.

Please note that the admission schedule is subject to change in case of unforeseen circumstances.
